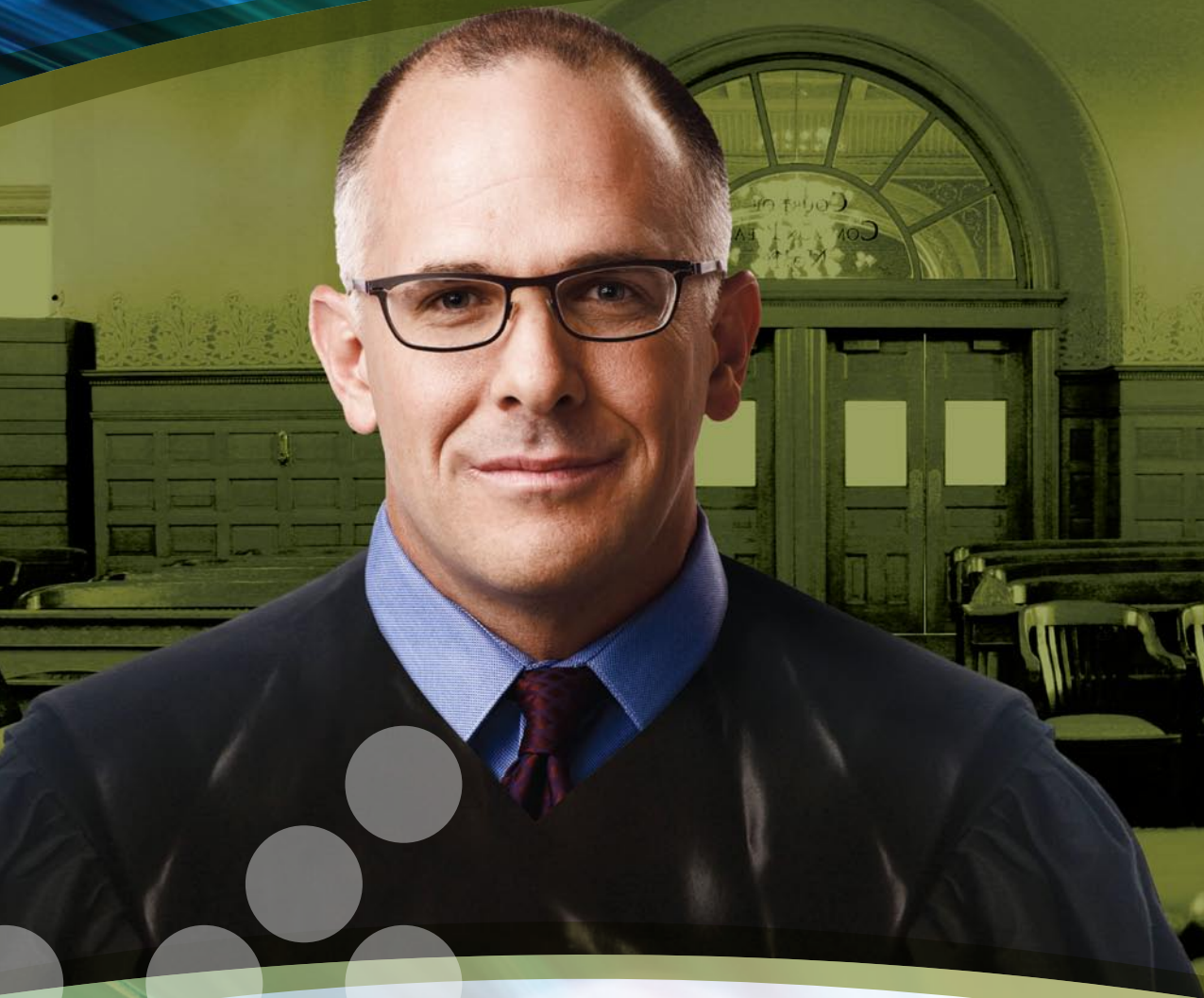

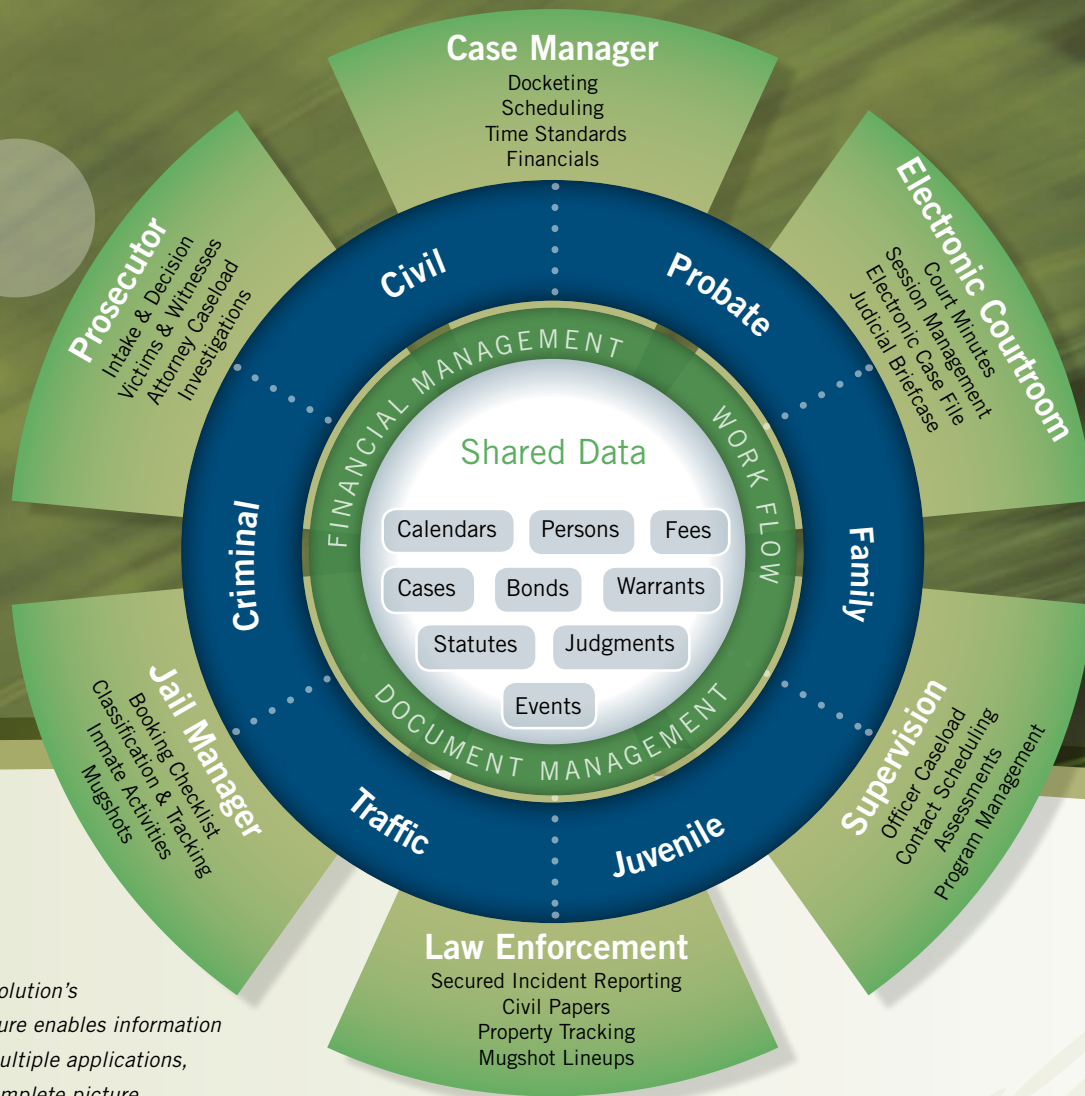
SUPERVISION
